This will confirm that as a family we urgently request your assistance in helping our sister, Marlene Legare obtain psychiatric help.

There is a history of mental illness in the family with one Aunt having spent time in treatment. Marlene's other children feel she has been in need of help for the past five years.

Since January 9th, 2006 she has flown back and forth from Maple Ridge, British Columbia on 5 different occasions and has caused us continuous grief since her arrival. She is totally unpredictable, scary and dangerous.

- Her two sons have had no contact with Marlene Legare for several years and her daughter refuses to visit because of her association with a
- On January 9th Marlene commenced legal action on behalf of our father for an insurance claim and has tried to take control of our father since this date
- On January 26th she unknowingly flew in from Vancouver and discharged our father 5 days early from the Grace Hospital and brought him directly to sign legal papers and to do some banking;
- On January 30th after having brunch she drove off with our father medications;
- On February 23rd she confirmed to us that she has listening devices and has been listening to our father's and guests conversations
- She has erroneously accused family members on several occasions of trying to kill our father
- She has attempted on many occasions to take our father, Lionel Bouchard away and he is terrified of her. On February 26th she broke the deadbolt and door to our father's suite and attempted to break the chain before being stopped. She then proceeded to physically assault one sister, Lynda Staub when she was asked to leave the premises.
