1. As per my telephone conversation, I am requesting the following statements, namely December 2005, January 2006, & February 2006, for review with past income tax, as well as am questioning the disbursement of my OAS/ CPP funds as I have been denied receipts for that time period, this despite repeated requests. In addition, my statements went missing when I was abruptly removed from home February 15, 2006, and my attorney would like to ascertain whether there was any misappropriation of my funds during that period of time, hence my request.
2. In addition, my attorney has also requested the Caisse be reminded and abide by the Privacy of Information Act in not divulging ANY information contained in this request.
3. As time is of the essence to resolve the ongoing conflict between myself and my son, am requesting that these duplicate statements - especially of negotiated cheques by way of power of attorney (which was immediately revoked) as I have absolutely no recollection of having signed this document, at a time when I was recovering in the hospital.
4. Please fax these documents at your earliest convenience to # 604-467-5630 and debit my account for the cost..
5. This is your release from me to the Caisse in order to facilitate this transaction.
6. As I intend to be away until this situation is resolved once and for all, and in order to avoid any further family pressure, as recommended by my attorney, I find myself wanting to avail myself with access to online banking in order that I may meet my monthly commitments. My current banking card # is 501 7931 7610 087213 and request to be set up with an Access Code and P.I.N. # in order to facilitate this end. Also would like to view my ongoing Visa Desjardins transactions which I assume can be viewed under the same Access & P.I.N. #'s?
7. As I have made this request to you personally over the telephone, there should be no question as to my identity. Again, I cannot stress enough that my communication and any information contained in this fax be treated with utmost confidentiality as afforded under the Privacy Act.
8. I trust this request is in good order.
9. I appreciate your prompt attention to this matter and would like to thank you in advance for your cooperation in this delicate matter as I do not wish to involve any community members, hence retaining an attorney to enforce my rights.

RE: UNAUTHORIZED REVOCATION OF LINE OF CREDIT

We have received your fax dated March 16th, 2008 pertaining to the affairs of Mr. Lionel Bouchard and the Caisse Populaire in Elie.

Although the documentation provided was not sufficient to allow us to express an opinion in the matter presented, we did have a brief discussion with the Manager of the Caisse to ensure that the Caisse had in fact acted in the best interest of the member whilst respecting all pertinent legal documentation in their possession.

While we are confident that such was the case; we are not at liberty to discuss the affairs of Mr. Bouchard with a third party without proper authorization. We strongly suggest that any further dealings pertaining to this issue be followed up with the Caisse in Elie, as they are the appropriate legal entity managing this account and would be best suited to respond appropriately based on the legal documentation held in the file.

Subject : Lionel Bouchard Account 2-4

1. Please remove Claire Demery as power of attorney as the power of attorney drawn up on January 27, 2006, was stolen from Lionel Bouchard's home by Andre Bouchard. From Elie to the Holiday Inn on Morrey Street, Andy took the time to *photocopy the stolen document* which is what Claire presented to your office. (Note the 239-xxxx fax # which is a Portage # where Andy lives!) The theft of this legal document, as well as cellular phones stolen, (Dad's and mine) and other items was reported to the RCMP in Headingley and Andy was arrested and charged with two counts of theft. Claire was never in receipt of the original nor ever authorized to use it. The power of attorney was paid for by Marlene Légaré at David Bradley's office and was returned to her by the RCMP in Headingley as Andy's had originally tricked his father into signing at the hospital, a power of attorney made out in his favour, which his father was not aware he was signing as Andy had slipped the power of attorney beneath insurance and licence renewal forms. Lionel Bouchard had been ADAMANT he was refusing to sign any power of attorney at that time as he was aware his son was trying to remove him from his home - which he did and which there is a Writ of Possession in process. The power of attorney made out to Claire in my possession was meant to be used only if Dad was unable to take care of his affairs and not intended to be used to override his banking and close down any line of credit while on holidays! It was never intended to control our father or his coming and goings especially when these siblings have shown over the past two years that their motives have only been self-serving, signing agreements they never had any intentions of honouring and coming against myself, the only one to stand up for her father's rights.
 2. In addition, please issue Lionel Bouchard a debit card and a P.I.N. to access his account from any ATM machine as Lionel Bouchard intends on travelling in the future and wishes to be set up for web banking at the Caisse so that his bills made be paid for and monitor activity in his account. Please fax me the information as I am accountable to his attorney and working on reconciling past accounts to determine what my father is entitled to.
 3. Lionel Bouchard will be bringing in a copy of the February 2008 power of attorney. Please ensure that according to the privacy act that the details contained within remain confidential. You will note that Lionel Bouchard's attorney has verified that the new power of attorney drawn up in February 2008 revokes any prior temporarily stolen in Claire's name and which photocopied power of attorney should never have been accepted in the first place.
 4. Please reinstate Lionel Bouchard's overdraft and increase to \$5,000
 5. My father currently has two caveats on title - one for a Life Estate eliminating any future rent, as well as a caveat for what is due him by Andre Bouchard, namely reimbursement of rent in the sum of \$15,000, and balance of the mortgage of \$5,000, and miscellaneous other charges to be accounted for scheduled to be dealt with on July 23, 2008. In addition, as part of his assets, please include a 2007 Dodge Caravan which he has full use of and will be gifted over to him once he is settled in his home again.

Brigitte,

In viewing my father's account, the unauthorized cancellation of the line of credit by Claire Demery has not been reinstated.

I am requesting that this be reversed to original status prior to having our father, Lionel Bouchard's account tampered with.

On January 12, 2006, I witnessed in total disbelief inside the Grace Hospital Cafeteria as Andy Bouchard skirted a power of attorney to be signed beneath insurance and driver license renewal papers as he deceived his own father into signing what our father was told were only renewal papers ~ all after my father steadfastly refused for an hour to sign any such power of attorney (in Andy Bouchard's favor) hardly forgetting all the years of abuse and usury the personal and constant attack on his father's character and dignity, the constant put-downs and degrading name-calling and utter disrespect and honor for his father telling him he is "confused" which in my opinion borders on a psychiatric evaluation for Andy Bouchard and not my father or anyone else. My father has recently disclosed information and vast ongoing abuse and the unbelievable extent of it & their personal vendetta against our father!

One small example is that from the period of 1990 to 2003, Andy Bouchard paid zero interest on the mortgage owed his father – unlike any other prudent business transaction. Our father, did not share ½ the crop every year and other amounts which should have been split with both parties as owners. Andy Bouchard also stole numerous trees that his father painstakingly planted and cared for over the years among numerous other events that displayed Andy Bouchard's true lack of character. Moving forward to mention continuous constant verbal abuse witnessed by many people over the years, family and friends.

Andy Bouchard, along with Lynda Staub and Claire Demery, then threw out their father's possessions ~ even buried some of them in the back yard, which their father found and dug up, this while his father was recovering in the hospital when he suffered a concussion while exiting the St. Eustache Church after a funeral.

Then Andy Bouchard and Lynda Staub deceived their own father into signing a rental agreement in St. Eustache. They lied and told their father the only way their father would get released out of the hospital was by going to St. Eustache Manor because of "home support" and that he would not be able to get home support in Elie and that he could return to his home "in the spring".

That is when I jumped on the next plane out to Winnipeg after hearing my father's fears as he shared them with me were realized at which point I took him home ~ much to the fury of Andy Bouchard and Lynda Staub & Claire Demery. My father had the Power of Attorney from Andy Bouchard revoked that very same day when he learned of Andy Bouchard's deception. I paid for a new power of attorney in favor of Claire Demery, which was

a disastrous mistake that I learned only after I realized she was in the same camp as Andy Bouchard and Lynda Staub for whatever their reasons! This power of attorney was in my possession when Andy Bouchard barged into his father's house - red faced and furious that his father had returned to his family homestead of over 50 years!

It is at that point that Andy Bouchard stole both my father's cell phone and my cell phone as well as my legal binder which contained this new power of attorney & all kinds of notes of information that my father had shared with me. The Winnipeg Police Dept. arrested Andy Bouchard for theft at the Holiday Inn on Sunday, January 29, 2006, , (where Andy Bouchard had organized a low-life plot using the same two Lynda Staub and Claire Demery

to ambush and railroad ~~on~~ their own father, my father, permanently from his family homestead). Andy Bouchard, Lynda Staub, Claire Demery, doesn't matter who, this is what happened, magically a copy of the power of attorney later surfaced. The Headingley RCMP returned the original power of attorney to myself which I maintain in my possession to this day.

The charges and "No Contact Orders " imposed by the RCMP naming Andy Bouchard suspiciously were dropped by Crown citing it's only a "family dispute"!!! That is when Andy Bouchard continued his act of the "good son image" and using the law for his personal vendetta to silence me using family members to lay false charges (deceitful lies) in an attempt to discredit myself and destroy my good reputation, business and personal life in

order to keep me out of the province of Manitoba so as to prevent our father from receiving the desperately needed help (rescue) as no one else ~~stand~~ stepped up to the constant bullying, manipulation & intimidation by Andy Bouchard!

My sister Leona Bouchard of Calgary had called my father and myself to warn us that Andy Bouchard had set up a meeting at the Holiday Inn to evict our father out of the 120 year-old Bouchard homestead as Andy Bouchard wanted family support to carry out this despicable and underhanded disgraceful plan. That is when their deceitful lies attacked my credibility. It was then Andy Bouchard must of realized that his sister Marlene Legare

would not back down and be intimidated. I would not leave my father to the vultures. Was Andy Bouchard exempt from honoring his agreement with his father? *An agreement of being loving and respectful in nature, between father and son, understandably would not need to be in writing...*

It was at this time that I learned from Portage Land Titles of one of Andy Bouchard's motives – which was a mortgage of \$185,000 registered only two days prior to his father's fall and another \$150,000 mortgage registered on the family farm...which inexplicably did not show up at Land Titles until February 15, 2006, the date Andy Bouchard and Claire Demery and Lynda Staub and Angie Bouchard moved our father from his home in Elie!

In his meeting with his father on August 11, 2008, Mike Slegers disguised as a hero, brought our father and Andy Bouchard together only to have Andy Bouchard arrive at the family farm with a psychiatrist . Andy Bouchard ~~still~~ determined to "**commit his father to a mental facility**", **jail** or at the very least some cheap retirement home for reasons only found in the dark recesses of Andy's ~~sick~~ mind that one cannot fathom - his own emotional and personal web that he is tangled up in and how the love of money (greed) and his own chauvinist pride and low self-esteem have driven him to where he lives now and how he treats everyone else as a predator ~ a wolf in sheep's clothing!

Andy Bouchard had procured from Lynda Staub paperwork from Land Titles to "release the caveats" our father's lawyer placed on Andy Bouchard's title which goes against proper protocol for any employee to draft in

advance, especially in light of knowing that the two parties are in the midst of a civil action, but that just shows how devious these two have been all along. After fleeing Manitoba to B.C. this spring to escape the abuse and manipulation and control by his own children, Lynda Staub then threatened to have her very own father (Lionel Bouchard) charged with "child abuse" **IF** he returned to Manitoba from B.C.!!!! which was reported to the RCMP at our father's lawyer's instructions but apparently not enough of a threat to have charges laid, but enough to almost cause our father to have a heart attack based on the worst sort of accusation one can endure!!!

In June, the RCMP were called in to order Andy Bouchard to release Lionel Bouchard's motor home from the locked-up shed on the Bouchard family farm. *Ken Beaudin felt threatened that Andy Bouchard was out-of-control and in such a state of mind that he feared Andy Bouchard could easily have assaulted him or worse!* Joe Hofer, a friend of my father from the Hutterite Colony, also encountered the same reaction from Andy Bouchard at a luncheon meeting when Joe questioned Andy on his father's return to his home at which point Andy Bouchard stood up and Joe feared Andy would get violent with him.

On August 18, Lionel Bouchard's lawyer learned that Andy Bouchard and Mike Slegers had unlawfully locked and barricaded my 2007 Dodge Grand Caravan, which my father has my permission to drive, in Mike's shed and taken away the keys, as well as my father's cell phone as they were controlling my father's actions, refusing to allow Lionel Bouchard to speak with his attorney, Winston Smith, myself, as well as Madeleine Fillion, his own sister, at this point his attorney Winston Smith realized the only option in my father's best interests and safety was to remove Lionel from the Province of Manitoba until the situation is resolved in a court of law. After the rescue of my father Lionel Bouchard, Mike Slegers and Andy Bouchard lay hiding in the bushes on Hwy. 26 **all night long hoping Dad's van would surface** as both had filled it full of our father's possessions. Acid was found poured on the rug which will cost \$1,000 to replace out, this after being ordered again by RCMP to release the vehicle and our father's possessions which they had confiscated in order to force our father to sign their new agreement.

Currently Mike Slegers is refusing to release Dad's blue dodge van as well as personal belongings including medication, passport, traveler's checks, etc., in a duffle bag in Mike's truck. Mike Slegers had taken away all Dad's vehicle keys and would not allow our father to drive or go anywhere until he signed the agreement he and Andy Bouchard had fashioned ~ obviously in Andy Bouchard's favor~ this contrary to Mike Slegers stating that he would only look after our father's best interests, without cost, then doing a complete 360 degree in Andy Bouchard's favor ~ which just goes to show how manipulative Andy Bouchard goes to get his way.

Mike Slegers is threatening to charge our father, and have our father lose his license out of sheer maliciousness, obviously with Andy Bouchard instigating behind the scenes as usual, tactics Andy Bouchard works best at. Mike Slegers had a diesel spill on his property of over 500 gallons which he blames Dad for his very own faulty, old worn out hose when he refused to allow our father to shut off the safety valve and now wants to charge our father Dad \$3,000 replace the full tank.

Mike Slegers had initially repeatedly invited our father to stay with him at no cost. Despite this, Mike Slegers has already charged our father \$400 for rent, reneging on his offer to help free of charge.... and requesting more rent while he brags about giving away \$50,000 to charity to avoid paying income tax! Mike Slegers stated recently he had \$185,000 to invest somewhere....

Andy Bouchard has done the same thing with his very own mother, refusing her to allow to go back to cancer treatment in Houston, Texas, where I had taken her the year before and treatment was working very well. However, Andy Bouchard and Lynda Staub could not wait to get their hands on our mother's estate and preferred she die. Now Andy Bouchard & Lynda Staub are fighting over her estate as Mom had told me in her hospital bed they would when she called to see me, at which time Andy Bouchard ensured that she not go, despite her signing a form stating she wanted to go back with me for her treatment in Texas, which Lynda Staub and Andy Bouchard had discouraged her from continuing. Then when she regressed, Lynda Staub flew her to Mexico, a third world country, at a cost of \$41,000 to detox at a Usana-related health pills glorified spa Lynda Staub pushes pills for, only to come home after being needlessly operated, so weak and to die on wheatgrass. There is no doubt in my mind, that our mother would still be alive today if they had not interfered with her treatment at the Burzynski

Clinic in Houston, Texas, a 25 year international renown cancer clinic famous for its cancer cure rate. June 2006, Lynda Staub had our mother exclude three girls out of her will, this while our mother was on morphine and after redoing the will of which she had power of attorney, Lynda Staub who works at Land Titles then transferred the land mentioned in the will into her name as well as our mother's husband's name jointly, *without his knowledge & which he has now hired lawyers to dispute the change!* 4

Andy Bouchard could not bear to see our mother live, and certainly did not want her to go back for treatment that had amazed the Winnipeg oncologists, and which medication Avastin was later approved in Manitoba a couple weeks before our mother died. Andy Bouchard carried our mother from her bed at home after he had her discharged from the Stonewall hospital when he learned I was around and that we had planned the trip. Andy Bouchard then took our ailing mother to the RCMP Detachment and in the video you can see our mother was totally out of it on morphine, and Andy coached her to charge me with Attempted Kidnap – to save her own life yet! My over 200 clients in B.C. could not believe the justice mentality in Manitoba – that would never have happened here in B.C. where one person's lies carried as much weight as they did in Manitoba!!! The charges obviously four months later were stayed as expected! The Winnipeg Free Press reporters could not believe it themselves and requested an interview which I granted and which there was ban of publication afterwards to "protect" the complainant – Andy Bouchard & family so the truth would not come out which it is anyways!

This has to be the worst case of senior abuse I have encountered and sad to say it is caused by basically one person who has now dragged, much to their very own demise, two or three main other family siblings to hide behind which is how he operates, sad but true!

I have yet to find one person to speak one good word about this brother ~ his actions speak for themselves....

This is simply scratching the surface of what has been transpiring in my father's life over the past couple years, this when he should be enjoying the fruit of his labour, not ***dodging his very own children's hatred, greed and blatant abuse!!!***
