Re: Incident #10-90183 - October 29, 2010, Winnipeg Airport

Attached please find an incident report obtained through "Freedom of Information" which occurred at the Winnipeg International Airport.

As a result of being paged by Westjet, my father was extremely concerned when he was confronted and interrogated by Michelle Staub, the daughter of Lynda Staub, (who Lionel Bouchard had a Protection Order against for the past year), as she passed through Airport Security on her way to Toronto! What we surmise is that Michelle Staub called her mother from her cellular as Lynda Staub quickly appeared, extremely upset, hurling accusations directed at myself as she walked into the airport.

Missing in this report is a statement from the officer at the airport who was assisting me in locating my father at the time. This in-house officer was walking with me towards the front doors to await the arrival by taxi of my almost 87 year old father, who had left the airport after being informed by both Westjet and Airport Security that I was already on the plane bound for Vancouver. Lionel Bouchard then left the airport as he was greatly concerned for fear of being harassed or accosted by the Public Trustee as threatened by the three children he had had protection orders against who anyone of which he feared might still be at the airport after dropping off Michelle Staub!

My father and companion were not allowed through security as Westjet had issued a duplicate boarding pass for me, which we were not aware of at the time, which occurred after we had separated when I left to return the rental vehicle. Both my father and companion were being assisted by a Westjet employee in checking in the luggage who at that time must have issued a duplicate boarding pass for me which prevented them from going through security.

Lynda Staub screamed at us that Dad had lost "60 lbs." and not "50 lbs." contrary to what Lionel Bouchard had just told his grand-daughter Michelle Staub, weight lost dieting as a result of his doctor's orders, whereby he is now at his ideal weight. Lynda's next false accusation was that I had "abducted our father", this in an attempt to charge me, fully knowing that our father had been escorted by two private investigators, hired by his lawyer Winston Smith, to drive him to the Regina Airport in August 2008, in order to avoid the same scene that I found myself running into once again, for the second time.

In October 2006, I was accused, this time by my brother André Bouchard of "attempted kidnap of my very own mother" to accompany her, at her request, to fly back to Houston, Texas, for cancer treatment. I was escorted off the plane and held in Remand, and living in B.C., was a "flight risk" according to these siblings, and held for four months while awaiting charges which were eventually stayed!

There is a history of false accusations, this being the third such false claim coming from these siblings, the previous one in August 2008 directed at our father's lawyer of the law firm Hook & Smith whereby he was also accused of "abducting our father".

In the security line-up, my father was questioned by the police asking "Mr. Bouchard are you OK?"

As I will be requesting an investigation with respect to malicious charges against Lynda Staub, and André Bouchard, it is critical that a statement be obtained from the officer who, while assisting me in locating my father, witnessed Lynda Staub who once again is trying to use the law to hide behind the abuse they have subjected our father to over the years.

Lynda Staub, André Bouchard and Claire Demery, in court affidavits in December 2009, have been trying to convince the Court to deem our very competent father a Ward of the Public Trustee, in yet another attempt to pressure our father to give up his claim to his life estate in Elie, Manitoba, the home he has lived in for over 50 years.

The past five years have resulted in constant threats, intimidation, unwarranted visits by the RCMP to my door in B.C., at taxpayer expense, where my father has sought refuge and safety for the past two years based on his counsel's advice, out of fear for his life, and has for the past five years been subjected to a stream of hurtful lies, both in B.C. and Manitoba, threats of child abuse for disciplining his children while growing up, all which have taken its toll stress-wise and health-wise on our elderly father whereby he now carries nitro in event of a heart attack and suffers from a bad case of shingles caused by nerves.

I fear if this harassment and these psychological attacks continue much longer, that Lionel Bouchard will have a heart attack as he is in constant fear of being committed, having had André Bouchard bring him to psychiatrists in the past, and on the farm in 2008, on the pretense of settling the life estate and monies due him, destroying his personal property while in the hospital in January 2006, disabling his motor home, repeatedly threatening, and has been falsely accused of being incompetent, all the while his own doctor, as well as the Mental Health Department in B.C. have declared him competent to handle his affairs. Lionel Bouchard holds a valid driver's licence to this day.

As his daughter, and having the power of attorney and health directive, I am seeking legal recourse to protect my father and his basic right to live without fear of losing his rights or shortening his life, this at almost age 87, when he should be enjoying his retirement, and not being hounded by three ungrateful children who despise him and are seeking to destroy him, having already stolen the past five years from him since kicking him out his humble farm home in Elie, despite a Life Estate Agreement he holds with his son André Bouchard of Portage La Prairie entered into in 2002 when Lionel sold the Centennial homestead for sentimental reasons to his son.

In addition, I was accused of numerous charges and was falsely incarcerated as a result of being a threat to these three siblings, as a certified financial planner, when called out to come to Manitoba, the facts soon become obvious to me as to what the siblings had been up over the years, taking financial advantage of both our mother and father. Rather than being exposed, they instantly and veraciously made me a target to discredit and defame me personally, and in my career, based on false allegations and twisted lies deceiving, for a time, the RCMP, the Crown and Judges with unfounded accusations. There were lists of individual's names used without their knowledge or consent, including a lawyer, and another professional as well as unaware family members and friends this presented to dupe a magistrate!

These certain siblings have since destroyed this family, all in the name of greed and they need to be held accountable for their actions.

I am currently in negotiations for a book based on the ordeal my father and mother, who has since passed away in January 2007, after being denied further treatment in the States at an internationally renown cancer clinic which boasts of a 93% cure rate, treatment not approved in Canada until three weeks prior to her death in January 2007. My step-father has had to sue Lynda Staub after discovering that she fraudulently added her name to transfer papers to property belonging to him, this as an clerk of the Winnipeg Land Titles office.
