This letter is written with regard to a letter our father, Lionel Bouchard received about re-testing for his driver's licence. He presently has a clean driver's abstract with absolutely no infractions or accidents. The only reason his name has come to your attention is because of a vindictive call to your office made by our sister, Mariene Legare who resides in Maple Ridge, B.C.

We believe our sister Marlene Legare is in need of physiatrist counseling and has been mentally and financially abusing our parents for several years. On Wednesday, May 10th, she was charged in Provincial Judges Court with assault on our father and mischief and restricted from having any contact with our father, Lionel Bouchard. Marlene resides in British Columbia and has flown irrationally to Winnipeg over seven times between the months of January and May of this year trying to take control of where she feels our father should reside.

Our father slipped on ice before Christmas and has since received a clean medical report as well as a vision test. He helps with the family farm and assists our brother Andy with farm work every fall. Our sister Marlene is very jealous that our father is helping Andy. Marlene is financially in debt and estranged for her husband and children. We believe she is trying to move residence from British Columbia to our father's home where she would not incur any living expenses. As a financial planner we suspect that she is wanting to handle all our father's financial affairs. By our father not having a driver's licence she would further control him if she is successful in moving in with him. We believe that this is the reason that she called your office and not because of our father's driving abilities.

Our father, Lionel Bouchard has done heavy equipment road maintenance all his life without a single accident. He lives in a farm community and requires his driver's licence to drive a short distance to attend community meals in the evening as well as to obtain his mail and groceries from the local merchant. Because he has been farming all his life he thoroughly enjoys and looks forward to putting in some hours combining on the family farm every fall. It keeps him active and gives him a purpose in life now that his family of nine have grown and left home

The family feels that because he has had absolutely no infractions or complaints from other drivers – only a call from a daughter who lives in British Columbia – that he should not be forced to be tested because of her phone call as it was not placed in good faith and not made for safety reasons.

We realize that it is your duty to remove unsafe drivers from the road and that you must act upon complaints from other drivers. This situation however, is out of the ordinary and not your usual case of someone having witnessed an accident or bad driving habits and we would greatly appreciate your reviewing this request for driver testing as we fell it is causing unnecessary stress on our father at this time, especially in light of the problems with Marlene recently.

We sincerely appreciate your reviewing this request for a driver examination and look forward to hearing further from you in this matter.
