On January 22, 2008, the day of my father's birthday, Lynda Staub and Andre Bouchard were at Dad's home and threatened to have "nothing to do with him" if he did not sign an agreement Andre Bouchard had been trying to have him sign for over two years, and then forcing him to take a \$2,000 cheque for "settlement in full" of an unregistered mortgage our father carried on his former home and acreage, threatening either he sign or they would "have nothing to do with him at all!" conversation witnessed by Michelle Dunbar, an employee of the Cartier Senior Housing in Elie!

Dad relayed to me that this was the same paper that Andy and his wife Angela repeatedly tried to get him to sign while in the hospital recovering from the head injury January 2006 sustained in the fall, so much so that Dad told me he would lock himself in the bathroom for hours and under the bed to avoid the harassment. Dad's roommate and the nurse also witnessed this deplorable behavior of Andy who would come after visiting hours to intimidate and bully his father.

As per instructions from my father's lawyer, we are seeking legal remedy and for charges to be laid against Lynda Staub for her taped threats, Claire Demery for illegally using a revoked power of attorney to close Dad's line of credit while on holidays, as well as requesting duplicate cellular records from M.T.S. in an attempt to breach me, Andy's threats of charging his father with trespass if he entered his home on the homestead in addition to Lynda Staub and Andy Bouchard threatening to "have nothing to do with their father if he did not sign the agreement" coercing him to sign on his birthday January 22, 2008. These siblings, as well as Angie Bouchard, need to be held accountable and charged with theft of their father's belongings, memories and paperwork (proof of what transpired over the years with respect to the purchase of the property and lack of payment on his son's part), this in accordance to their own admission on several emails, this at a time when our father was in the hospital recovering from head trauma, thereby further traumatization when he was discharged with no home or possessions to go to!

At 84 years of age, this father of nine, has the right to enjoy his retirement and to live out the rest of his days in peace in his home of over 50 years without further "abuse and threats" coming from his ill and greed-motivated children who have shown not one bit of love over the years, but rather chosen to intimidate and use abuse and make fun of their father, disrespecting his role as their father.



Statement from Marlene Legare, daughter from Maple Ridge, B.C.

April 12, 2008

When Dad came in from spending time alone outside, this after receiving very disturbing threats on his cellular from his daughter, Lynda Staub, of Winnipeg, it was obvious he was physically shaken from the lies and accusations!. As he walked to his bedroom, he mentioned that his shirt was wet with perspiration and that he had to go change.

The next day, complaining of a sore back, my father - still shaken, asked me to take him to the Care Clinic here in Maple Ridge immediately after church whereby the on duty physician confirmed that his blood pressure was extremely high. It had been normal the day prior to this incident as Dad takes his blood pressure regularly having recently purchased a blood pressure machine while on holidays in the States.

Dad was concerned about his heart as he mentioned to me the day before that Lynda and other siblings had been bullying and manipulating him for years, and in his words **"they are trying to give me a heart attack!"**

My father carries "nitro pills" in his wallet as a precaution but has never had any heart problems.

Concerned about my father's reaction to this intimidation and continued abuse by his daughter and other family members which escalated noticeably after his slip and fall on ice in December 2005, at which time my brother made it very clear to me that our father would **never be returning home**, that I played the message Sunday night to his attorney in Winnipeg, whereby **he advised turning the tape over to the RCMP before Dad has a heart attack** and in **order to ensure his is not threatened and to ensure his safety when he returns to Elie**, Manitoba, his home all his life, this now after having had to commence litigation against his son to regain what is rightfully his and has been stolen from him over the years!

Also a very real concern is that **my brother and sisters try to make good their threats to have my probation revoked by trumping up a created situation, as they have learned to do so well and have gotten away with it quite often in the past using lies and false accusations** or by manipulating our father once he returns to Manitoba, through medication, which my father admits occurred on at least once occasion, on the day he was dragged to court February 15, 2006, of which he has no recollection of attending the courtroom, when my brother tried unsuccessfully to obtain No Contact orders against myself which were dismissed for lack of evidence, this also the **same day my brother and sisters chose to evict our father from his home of over 50 years!**

April 12, 2008

TO WHOM IT MAY CONCERN:

On Saturday, **I observed Lionel Bouchard** sitting outside on the deck for over an hour **after retrieving on his cellular phone several very disturbing and utterly outrageous threats from his daughter Lynda Staub!**

Mr. Bouchard seemed to be bewildered and had a strange and lost look on his face.

He continued to sit outside but I could tell that phone call had upset him so much he just didn't seem to know how to take and handle such mean and hurtful lies from his own daughter.

He was actually shaking. This seemed to really have blindsided him and broke him up like his heart was just torn out that his own daughter Lynda would go to such lengths to continue to try to control and manipulate him.

I was concerned enough about his reaction to the phone call that I feared something might be physically wrong with him, so I told his daughter Marlene Legare to make sure he was okay.

You could see on his face he had never been in that situation before. He just couldn't believe what he had just heard. It's one thing to have lies thrown at you, but these types of lies from your own daughter for any reason just to get what she wants is simply quite disturbing and shows not only desperation but borders on dangerous.

Unauthorized Power of Attorney re M.T.S. Cellular # 781-6387 - Lionel Bouchard

In mid February 2008, I enquired into my father's cellular bill as my father was complaining to me that it was quite high - as noted from the March 24, 2008, disconnection notice. My father authorized M.T.S. to discuss his plan with me at which point I noted there were no free evening or weekend minutes. The plan was upgraded to a more suitable plan, for less money, and I was able to procure an \$85 credit on the account.

As a precaution, anticipating resistance from Andre Bouchard with respect to settling a Life Estate with our father, I had M.T.S. make a notation on file to relay account information to my father and myself exclusively and under no circumstances to any other family members. (At that point in time I did not have the power of attorney as my father was still in Manitoba.)

Recently, I decided to check on the account as Lynda Staub threatened to have my probation revoked for contacting my father even though, at my father's request, the No Contact was approved November 2007, in Port Coquitlam, B.C.

Sure enough, it appears that Claire Demery called in on March 26, at 1:50 p.m. whereby she faxed a copy of a power of attorney dated January 27, 2006! I had been present for the revocation of the initial power of attorney made out in favour of Andre Bouchard & Lynda Staub, (which Andre had tricked his father into signing at the Grace Hospital by placing it beneath insurance renewal paperwork he was having him sign) and which I was present at the time and was horrified at his actions and the smoothness of executing this trickery against our father who, for over 1/2 hour, was adamantly refusing to sign and which he recently told me that, while in the hospital, Andre and Angie Bouchard were constantly pressuring him to sign paperwork, which he was refusing, and which Dad admitted he had to resort to locking himself up in the bathroom and hiding under his bed to escape! Dad's roommate commented to him how despicable his son's actions were towards his father, this at a time when he almost died from his head injury and was in the process of recovering while in the hospital for a month-long stay. The nurses also noted this harassment.

I paid for, and had, and still have in my possession, the original power of attorney made out in Claire's favour, the exception being when the RCMP recovered it from Andre Bouchard after he was charged with two counts of theft of my binder (which contained this power of attorney) while I was at my father's home in Elie, January 29, 2006, along with my father and my cellu-lars - leaving us without any means of communication, this after Andy arranged a "family gathering" at the Holiday Inn in Winnipeg on the pretense of visiting with an Uncle from Kenora. I believe it was at this time that Andre Bouchard had the opportunity of photocopying the power of attorney as well as other notes in my binder which recently been used without my father's consent.

My sister Leona Bouchard of Calgary was on the telephone when Andy walked into my Dad's home in Elie. Andy was so infuriated at being exposed when he learned that Leona was warning us about the motive behind the meeting which was to gang up against our father in order to move him out of his home and into the Manitoba Housing Complex in St. Eustache. At the restaurant, Lynda Staub and Claire Demery physically grabbed my father from my care and pushed him into Lynda's vehicle, without his jacket - this after being discharged only two days prior from his 30 day hospital stay after falling and suffering a head injury! Later Andy faxed a copy of the title to the property my father's home of over 50 years is situated on, and as there had been a No Contact order in place in favour of my father and myself against Andy for his actions, he retaliated by ordering the RCMP to have me removed from my father's home, (which I knew at the time legally he could not make this request), also citing that he had had legal counsel from, which in hindsight I do not believe. As I did not wish to have a scene, I respected the RCMP request to leave that night and took a motel room in Winnipeg - this after I had come out for only a couple days to ensure my father's wishes to return home got accomplished and who had been discharged from the Grace Hospital into my care pending home support!

Brian Skinner of M.T.S., advised me that the copy of the power of attorney was faxed from 239-0106, identified as MegaComputers, a Portage La Prairie telephone # - most likely from Andre as he lives in Portage.

Also at that time, Claire Demery requested copies of the August/September/October/January/February/March bills (Claire already had taken Dad's cellular bill on January 22, the day of his birthday, when he complained about his bill, and at which time Claire stated she would look into his plan, and did nothing about it, but did take a copy. My father made a special trip to Teulon to retrieve this bill from her when he realized that at Christmas time he had called me, and that his bill did indicate that there was a call of a couple seconds as he reached my answering machine and left a brief message to wish me a Merry Christmas.

The \$36 charge for these duplicates is currently being credited back to the account. The duplicates arrived last week as my father's mail is currently temporarily being redirected by Canada Post to Vancouver. The intentions of Andre/Lynda/Claire was to have me breached for contact had they found one call on his cellular as evidenced by Lynda's recent threats to her Dad last week!

The transcript of the court case on February 15, 2006, indicates that Claire Demery had never received the power of attorney, and was at no time authorized to use this document, nor was it ever in her possession, this Claire stated under oath in Portage La Prairie, when she, along with three other family members, sought and were denied a peace bond against me.



Thanks for passing on this email; however, understandably, there are serious errors in it.

First of all, the statement about Roland is wrong. Mr. Slegler has a written agreement. He did not allow himself to be taken advantage of by his family. He also has it in writing that a nurse will be brought in - regardless of how much it costs to take care of him should he ever need it. So - check your facts first before believing what comes out of the devil's mouth. Also, Andy lied, he did have contact with someone - Roland Bouchard, and he is choosing to twist the facts - as usual.....as over the past few weeks, I have noticed the same pattern over and over of him changing the truth to suit his own agenda.

Another myth, the police never came to the Esso while I was there for over 3 hours enjoying speaking with the locals.

However, after Thursday night going in to the detachment, Andy had Dad him call me to say that he did not want company and that he wanted to rest. So I dropped in for barely 20 seconds at the door, saw that Andy had upset him, gave him his prune juice and then left. 

1. Over the past month, I have not received any mail sent to my post office Box 81 Elie which has been redirected to my daughter's address in B.C. since September 2008.
2. My mail stopped arriving about three weeks ago. According to Elie Post Office on March 20, two pieces of mail had just been sent that day which arrived on Monday, March 23, 2009.
3. In researching my facts, this is what I am aware has not arrived and was mailed:
 - Desjardins Visa Card statement mailed February 17, 2009
 - Bank of Montreal statement mailed February 25, 2009
 - M.T.S. cellular bill mailed February 22, 2009
 - Staples Card mailed February 25, 2009

These are the items that I have definitely confirmed with the sender.

4. This comes after a complaint to Canada Post about theft of a MasterCard mailed in March 2008, whereby I believe that my son Andy Bouchard approached the Postmaster to retrieve my mail, possibly using a revoked power of attorney which he was aware of, as well as having my mail redirection address in B.C. disclosed to him in contravention of the Privacy Act.


