



Dear Mr. Lachance and Ms Waldner:

Re: Personal effect of Lionel Bouchard

As you are no doubt aware, this firm acts for Lionel Bouchard, with regard to family business matters. In that regard, Mr. Bouchard has certain personal property presently located at Mr. Mike Slegers residence where our client had been residing for a number of months.

Mr. Slegers is aware that Mr. Bouchard has left the province, but my client left before removing all his personal possessions from Mr. Slegers' property. Mr. Slegers confirms that he has some of Mr. Bouchard's personal possessions on his property and, at the time that I spoke personally to Mr. Slegers on August 19, 2008, he requested that all Mr. Bouchard's possessions be removed from his property and I agreed to assist in that regard.

Would you kindly arrange with Mr. Slegers to attend at his property to take possession of Lionel Bouchard's following personal possessions:

- 1. Black leather duffel bag left in Mr. Slegers truck on August 19, 2008, and which contained the following items:
 - a) New blue sports jacket;
 - b) Medicine pack/nitro pills;
 - c) Passport
 - d) Puffer;

- Traveller's cheques;
- Address book and other papers; n
- Post office box kev;
- Mr. Bouchard's blue Dodge van; 2.
- A plastic bag of approximately 50 keys that was left in my client's bedroom in Mr. Slegers' home, together with a cardboard box also 3. from the room that contained other personal papers. This cardboard box and keys were supposed to have been packed in the 2007 Dodge van that was taken possession of on August 19th;
- One set of 2007 Dodge van keys. (There were two sets left at Mr. Slegers' home and only one set was given when the van was picked 4. up on August 19th. If the set is not there ask if Andy Bouchard has the set and ask him for it.);
- Brand new cellular phone that Mr. Bouchard obtained recently; 5.
- Fax machine purchased by my client's daughter, Marlene Legare, placed in Mr. Slegers' home for the purposes of 6. communicating between her, her father and Mr. Slegers;
- Television; 7.
- New black Lazy Boy chair; 8.
- New iron and ironing board; 9.
- Foot bath; 10.
- Humidifier; 11.
- Sleeping bag; 12.
- Pictures and albums; 13.
- Case of food, including popcorn and macaroni; 14.
- Beer and liquor; and 15.
- Cowboy boots and clothing. 16.

I am advised that all the above items can be packed in my client's Dodge van. There is also a bed, hide-a-bed, old dresser, table, chair and a mattress. If there is no room in the van, the bed and hide-a-bed can be disposed of, as you see fit, and not packed in the van. In addition, the dresser, table, chairs and mattress can be thrown out.

If there is any difficulty in arranging to meet Mr. Slegers to pick up my client's personal possessions or you are concerned for your safety or a possible breach of the peace by Mr. Slegers, you could call RCMP Sargent Jolicoeur of the Headingly detatchment for assistance. If you call the RCMP, explain that you have a letter from Lionel Bouchard's lawyer authorizing you to pick up his things at Mike Slegers' place and you need assistance. Mike Slegers' phone number is 353-4065 and he has advised me that he generally can be reached in the early morning or between noon and one o'clock.

When you have completed the pick up of the property, please call my office to report and also call Lionel Bouchard and let him know.

Two additional copies of this letter are being provided so that you can give one to Mr. Slegers for his records and the other to the RCMP.

I, MICHAEL BERNARDIS SLEGERS, of the Town of St. François
Xavier, in the Province of Manitoba, retired,

MAKE OATH AND SAY THAT:

1. I am a personal friend of the applicant who is presently living with me at my residence at:

7359 Hwy 26 St. François Xavier, MB R3L 1B6

2. The applicant has been living with me for about two weeks having returned to Manitoba to live in his home at or near the Town of Elie in the Province of Manitoba, which home is hereinafter referred to as the "Lionel Bouchard home".

- 3. I have known the applicant and his family for many, many years and was shocked at the disrespect many of the children of Lionel Bouchard have demonstrated towards him, including the respondent, André Lionel Bouchard, after his release from hospital in February 2006 following his unfortunate accident. I specifically informed the respondent, André Lionel Bouchard, at that time, that he was not honouring his father and that I, Michael Bernardis Slegers, would work at bringing peace among the family members.
- 4. In or about the early summer months of 2006, as a result of my expressed concern for the welfare of the applicant, the respondent, André Lionel Bouchard, visited me at my residence and informed me that he was going to fix up the Lionel Bouchard home so Lionel Bouchard, the applicant, could return to the home to live and enjoy it as he had prior to his accident in December 2005. The respondent further confirmed that his father would live in the Lionel Bouchard home free of charge. These commitments were confirmed to me by the respondent, André Lionel Bouchard, with a handshake after I told him that I would only shake his hand if he intended to follow through with his commitments as stated herein.
- 5. I am aware that since sometime after the commitment he made to me as referred to in paragraph 4 herein, the respondent, André Lionel Bouchard, rented the Lionel Bouchard home to a resident from, a nearby hotel, a person who I understand to be Jack Bock.

6. I make this Affidavit bona fide and in support of an Order from this Honourable Court to restore possession of the Lionel Bouchard home to my friend, the applicant, Lionel André Bouchard.

attorney. Mike has not returned any of these items, although I have requested their return on a number of occasions, either directly or through my attorney.

- 32. I have also asked Mike for my own vehicle, which he refuses to release from his residence and to allow me to arrange to have picked up. In October 2008, after sending someone to winterize my motor home left adjacent to the Bouchard Road. I discovered that the unit had been disabled. I had to secure CAA to move it to a safe location so that it would not be tampered with any further. The unit had been left unlocked in the event the neighbor had to move it; however, it was now locked up tight and the spare keys normally kept on the outside, which Andy knew of their location, were found inside after I called in a professional to open the unit for CAA, this after calls to Andy, Lynda Staub and Claire Demery to return my keys went unheeded.
 - 33. When my daughter's Dodge Caravan was handed over to the investigator to arrange for its return to Vancouver, British Columbia, it was loaded down with many items that I did not require, or own, including oil rags, gas, oil cans, including some type of acid which damaged the interior of the car, resulting in repair costs for a new carpet and interior van cleaning charges in the total amount of \$953.69 plus taxes. Attached hereto and marked as Exhibit "G" to this my Affidavit is a copy of the repair estimate.
 - 34. I suspect that the damage done to my daughter's van was caused by Andy or under his direction.

Am faxing with request to assist in retrieving my vehicle and personal possessions which dike Slegers has requested through my lawyer be removed from his property. Of utmost priority is the black duffle bag and new sportsjacket that was in Mike's truck when he insisted on driving me to my lawyers ffice in Winnipeg, despite repeated instructions from Winston Smith not to attend, and whereby Mike & andy both attended his office the day I left for my own safety. - has also spread rumours that day after I left Manitoba stating that I was in a hospital in B.C., the next nours is that I was a messy housekeeper (take a look at his disgraceful premises!) and that I was a slob to e ladies in the Elie Manor and not to allow me in. also called Don Desilets, committee for the Manor ing him that I was no longer a "resident" and to take my name off the waiting list. calling Mike this morning. Suzie Walder was advised that my van was parked between Mike's boat and er and that Mike was "running out to Portage to discuss with Andy not to allow my vehicle out & that he ted \$5.100 for expenses of which he did not clarify.

e told my daughter Marlene Legare in B.C. that he would do anything for me and that he would not age me for rent. He also told Suzie Waldner and John Lafreniere that just recently. Now he has charged

Complaint - Michael Slegers - Crime Watch Member

1. While living at Michael Slegers over the summer months. I noted some issues which are clearly violations for any Crime Watch Member.

- 2. To save \$40. Mike bragged to me that he dumped his sewage, against municipal regulations, in the bush in his back yard.
- 3. Mike refused to allow me to turn off the safety valve of the fuel tank in his yard when he requested I fuel up his truck. The very old hose sprung a leak to which Mike blamed me for the years of wear and tear. Mike then immediately replaced the hoses and now shuts off the safety valve. However, he now harasses me for payment for the 500 gallon he claims was in the tank, though his equipment is his responsibility. The soil in the spill area last June should have been trucked out as it can contaminate the river nearby. In fact, since being escorted from his property. Mike is now demanding \$5.000 for his trouble.
- 4. When Mike invited me to live with him and to assist me to fight against Andy Bouchard for my life estate, similar to his. Mike was prepared to put out \$20,000 of his own money to fight my cause. He would not let me live in my own motorhome on his property, insisted that having a motorhome in the yard was against municipal regulations, and forced me to move out of his fifth wheel into his home despite knowing that I am allergic to smoke as he is a chain smoker. Then he demanded rent of which I paid \$400, this after pleading with me to move in and he would not ask me for a dime and I could live rent free with him for the interim. Mike, I note, has a bait and switch mentality. He also started negotiations on my behalf with Andy and took over and wanted to have the power of attorney changed from my sister and daughter to himself, and he and Andy Bouchard took me to Barry Greenberg in Portage who would not draw up a power of attorney in their favour. Also, Mike and Andy were trying to get me to fire my lawyer, and confined me to any activity that only they were present basically keeping me against my will with threats and infimidation and promises of procuring me a home not mine though.

- 4. Mike Slegers has a life estate only and has not farmed since the sale of the existing acreage he lives on. Yet he continues to order fuel for his two tanks on his property from Marquette Co-op under the guise of Riverview Farms which is non-existent. The wiring on the house and condition of his yard in my estimation are a health and fire hazard as he refuses to maintain his residence and ensures no one comes into his yard as he has two very vicious dogs that are quite often on the loose.
- 5. When Laurent Houde recently reported Mike Slegers to Rick Desilets of Desilets Insurance in Elie. Mike received a letter the next day informing him to turn in his-plates. For years and years, Mike has been defrauding taxpayers and burning purple gas in his vehicles. He should be accountable to reimburse or be fined for procuring purple gas in contravention of regulations as he is so quick to turn in others, he should be held to the same standard.
- 6. As a member of Crime Watch, one would anticipate a background check is done on the parties involved. Had one such been done, the records would indicate that the ex-Mrs. Slegers has a restraining order against Mike for terrorizing her with a shotgun in the back lane of her residence in Winnipeg and she as well the children fear Mike to this day. As a blackmail tactic to have his wife return to the farm, he threatened and did turn in his teenage son for a few marijuana plants he was growing on the property for which his son was acquitted when the judge realized Mike's real motives were to control his wife!
- 7. Also, Mike informed me that he gets his cigarettes through a third party who gets them tax free in Headingley at the Tax Free location on native land.
- 8. Currently Mike is trying to overturn the three Protection Orders I have in place required for when I am awarded possession my home in Elie based on the fact he states I no longer have any ties in Elie and no longer a resident of Manitoba. In fact, he is in large part the reason, I am not yet in my home in Elie because of pretending to be a hero and turning on me two days before I had an excellent chance of gaining possession of my home in court.
- 9. I also am of the opinion that Mike made good his threat to report me to the motor vehicle branch to take away my driver's licence of which I am proud to state that I have a clear driving record as I was made to undergo another medical to renew it in June 2009.
- 10. Mike is forever looking to report anyone he can at any time, going from coffee shop to coffee shop looking for anyone he can report and for this receive he should not be a member of crime watch in my opinion.
