JANUARY 1/2006 - DESTROYED MY PERSONAL BELONGINGS WHILE I WAS IN HOSPITAL. REFER TO LYNDIA'S EMAIL, KICKED ME OUT OF MY HOME Feb. 2006. PUT PEAR INTO ME AGAINST MARLENE WHO WAS ASSISTING ME BY TELLING ME THINGS LIKE SHE WAS GOING TO BURN MY PLACE DOWN, AFTER MY MONEY, WANTED TO MOVE IN WITH ME, WANTED TO COMMIT ME, WHEN OPPOSITE TRAIL SEIZED MY VANS & DISABLED MY MOTORHOME, USED REVOKED POWERS & ATTORNEY TO TRY TO ACCESS MY CELLULAR PHONE, STOLE MY MAIL, CLOSED DOWN MY CAISSIE OVERDRAFT, TRIED TO ACCESS BANK OF MONTREAL, SIGNED AGREEMENTS THEY REFUSED TO HONOUR TO ALLOW ME IN MY HOME, SENT RCMP ON FALSE CHARGES TO BC WHERE I WAS LIVING WITH MARLENE.

I FEAR THAT THE NEXT STEP WOULD BE TO DRUG ME AGAIN & THEN COMMIT ME AS HAS BEEN ANDY'S PLANS SINCE 2006. EMOTIONAL, PHYSICAL ABUSE (STRESS) & FINANCIAL ONGOING SINCE 2006. CONCERNED ABOUT MY HEALTH, DOCTOR HAS GIVEN ME NITRO SPRAY FOR HEART ATTACKS. HAVE A CASE OF SHINGLES BASED ON STRESS. CONSTANT FEAR OF BEING APPREHENDED AND COMMITTED AS EVIDENCED BY THEIR INTENTIONS. JAN. 29/2006, LYNDIA HAD PUSHED ME INTO HER CAR & AWAY FROM FAMILY GATHERING WHEN I DROVE THERE WITH MARLENE LEGARE. THIS ACTION BASED ON ANDY'S DIRECTIONS AFTER ANDY WAS ARRESTED FOR STEALING MY CELLULAR PHONE AT MY HOME IN ELIE AFTER ANDY WAS IN A RAGE FOR BEING EXPOSED BY HIS SISTER OF CALGARY WARNING ME ABOUT ANDY'S PLOT TO
